We now host sessions online and in Dover, Newark, and Wilmington. Also did outside coaching and base building work to develop the civic skills of volunteers.

Community project support and coaching. We provided 1-on-1 and small group coaching for individuals and teams on how to improve their work (e.g., action planning).
